It is important to your child's support that you let us know immediately of any change in family circumstances, e.g., parents' separation, any serious illness or deaths of loved ones or of court orders which are in force. This helps us to support your child during difficult times in their lives.

## 1.2. School Staffing

The school caters for nursery and primary-school-aged children, that is, pupils aged 2 to 12 and currently comprises 8 mainstream classes with 5 supported classes located in close proximity to the peer age mainstream class:

- Early Learning and Childcare (Nursery), Primary 1 to Primary 7 (P1 to P7).
- The whole school roll is currently 264 - 68 [MK1] in Nursery, 196 P1 to P7.
- Senior Leadership Team (SLT) - Head Teacher, Depute Head and School Business Manager
- Extended Senior Leadership Team (XSLT): Principal Teacher Support for Learning, Principal Teacher of Learning and Teaching, Early Learning and Childcare Manager.
- 13 classes - 17 Class Teachers-including part-time staff
- 25 part-time/full time Support for Learning Assistants including staff employed to support Covid recovery
- ELCC Team - 1 Senior Early Years Practitioner. 2 Lead Early Years Practitioners, 13 Early Years Practitioners (including part time staff), 1 Early Years Practitioner in Training and 3 Part-time Early Years Support Workers
- Learning is also supported by specialist teachers of Music, Art, P.E. and Drama.
- Fiddle / violin and woodwind tutors visit once a week.
- 2 school Janitors
- 2 part-time Auxiliaries
- 2 part-time Office Staff
- 1 Head Cook.

- 4 Kitchen Assistants including part-time staff.
- 6 Cleaners.<sup>[MK2]</sup>

These staff help us to work with you in meeting your child's needs. If your child requires additional support and involvement from any of these agencies, you will always be asked for your consent.

The school is non-denominational and holds whole-school opportunities for religious observance.

## 1.5 Early Learning and Childcare Registration and Enrolment:

Each year in February Education, Leisure and Housing Services announces Nursery registration procedures by advertising in 'The Orcadian'. This is the first opportunity you have to register your child for a pre-school education place.

**If your child turns three years old between the 1 March 2022 and 28 February 2023,** they become entitled to their first year of funded Early Learning and Childcare place the term after their third birthday as below:

1 March – 31 August 2019	16 <sup>th</sup> August 2022 (Autumn Term)
1 September- 31 December 2019	5 <sup>th</sup> January 2023 (Spring Term)
1 January – 28 February 2020	19 <sup>th</sup> April 2023 (Summer Term)

Though most parents choose to put their child to an Early Learning and Childcare setting in their local area, some parents may find it more convenient to use Early Learning and Childcare elsewhere. These requests cannot be guaranteed unless there are enough spaces. To ask for an alternative placement is called a placing request. A valid reason such as 'siblings attend school already' or 'moving house' may be considered. Parents may want to choose another setting because of their childcare arrangements. ### Early Learning and Childcare times

Early Learning and Childcare sessions are 2 hours 30 minutes each day for pupils, plus a 10 minute period at the drop off and pick up times each session to allow for less congestion in the cloak area and to give parents a chance to speak informally with the nursery team.

## 1.6 The School Day (P1-P7)

School Staff begin playground supervision at 9.10 am. Because no supervision is available before this time, children should not arrive at school until 9.10 am.

During intervals janitors, auxiliaries and support for learning assistants supervise the children. In addition, the head teacher, depute, business manager and principal teachers are on call to provide support; parents are kept informed if there are any significant issues. There is always access to the building for children who need it.

## 1.7 Attendance, Absences, and the Duty to Attend School

Please read the following Council guidelines issued by the Education Service concerning attendance and absence.

It is the responsibility of parents of a child of school age to make sure that their child is educated. Most do this by sending their child to school regularly. Attendance is recorded twice a day, morning, and afternoon.

Absence from school is recorded as authorised, that is, approved by the education authority; or as unauthorised, that is, unexplained by the parent (truancy).

Please let the school know by letter or phone if your child is likely to be absent for some time and give your child a note on his or her return to school, confirming the reason for absence. If there is no explanation from a child's parents, the absence will be regarded as unauthorised.

Please make every effort to avoid family holidays during term time as this disrupts the child's education and reduces learning time. The head teacher can approve absence from school for a family holiday in certain extreme situations, for example, in traumatic domestic circumstances where the holiday would improve the cohesion and wellbeing of the family. Please discuss your plans with the head teacher before the holiday. If the head teacher does not give permission before the holiday, it will be recorded as unauthorised absence. The head teacher may also exercise discretion when a parent can prove that work commitments make a family holiday impossible during school holiday times. Normally, your employer will need to provide evidence of your work commitments. Absence approved by the head teacher on this basis is regarded as authorised absence.

Parents from minority ethnic religious communities may request that their children be permitted to be absent from school to celebrate recognised religious events. Absence approved by the head teacher on this basis is regarded as authorised absence. Extended leave can also be granted on request for families returning to their country of origin for cultural or care reasons.

The Senior Leadership Team review attendance at least twice a term, noting absences of 90-95% and those below 90%. Absence rates below 90% may be followed up with

parents/caregivers to encourage improved attendance. This could include a discussion on the reason(s) for absence, establish if there are underlying issues which may result in further absences and explore if there is any support or assistance that could be put in place to minimise future absence.

A supportive approach is taken to unexplained absence - however the education authority has legal powers to write to, interview or prosecute parents, or refer pupils to the Reporter to the Children's Panel, if necessary.

## **1.8 School Dress Code**

The dress code was agreed in consultation with parents, pupils, staff, and Friends of Glaitness School (the Parent Council). It incorporates a range of popular purple/dark green/white clothing items, e.g., polo shirts, sweatshirts, fleeces, PE kit.

Wearing school uniform contributes to a positive school ethos, helps avoid discrimination and reduces peer pressure to wear expensive designer clothing. A school's reputation can also be enhanced in the local community by supporting the school dress code.

It is not necessary to purchase a uniform with a logo, and parents are free to purchase from any trader. School uniform with logo items can be ordered from:

## Clothing for Activities

The appropriate clothing and footwear for PE is a T-shirt, shorts, and gym shoes with non-marking soles. If a child has long hair, it should be tied back. Your co-operation is requested to ensure that pupils are equipped to participate in the PE lessons safely.

Please ensure that all items of clothing are **clearly labelled**; particularly sweatshirts and PE clothing which are easily lost. A protective apron or an old shirt should be worn for art and craft activities. Please help the school and the education authority by making sure that pupils do not bring valuable or expensive items of clothing to school.

The wearing of jewellery is discouraged. If a child has pierced ears, then studs may be worn. Children will be asked to remove jewellery.

In certain circumstances, appropriate clothing and footwear will be necessary for school trips and extra-curricular activities.

If you have any queries regarding the school's dress code, please contact the head teacher.

## 1.9 School Catering

All schools in Orkney provide subsidised meals, either prepared in-house or, in some cases, at a neighbouring school. Our school provides meals prepared at the school. Orkney's school meals service aims to provide children with a high quality and varied diet. Copies of the menus are available from the school and on the website.

For more information on catering provision please contact the school directly.

## 1.10 School Meals at Glaitness

School meals at Glaitness are prepared daily in the school kitchen by a team of catering staff. Pupils in nursery may eat lunch in their setting or join P1-P7 who eat their lunches in two settings in the dining hall.

In January 2022 universal free school meals became available to all P1-P5 pupils. For other pupils, meals cost £2.70 each and payment should be made directly to the school meals staff between 9.10 and 9.30 every morning. Parents can either give their child money daily or buy a book of ten tickets in advance from the school kitchen staff and give their children daily tickets rather than money. A book costs £27.00 and parents can come to the school between 9.10 and 9.30am to purchase them or send money with their child. Cheques should be made payable to 'OIC School Meals' and a valid cheque guarantee card number must be written on the [back](#)<sup>[MK7]</sup>. Please **ensure daily tickets are identified with your child's name and class, and their choice of meal for that day.**

The food is very healthy and wholesome, and the children can have a great variety in a week. Options to encourage healthy choices include:

Option 1 Soup, any main course, fresh fruit

Option 2 Any main course with soup or pudding

Option 3 Soup or fruit, sandwich, pudding



It should be noted that as part of the Nutritional Requirements for Food and Drink in Schools (Scotland) Regulations 2008, puddings can only be served as part of a meal and not purchased separately. Milk or water will be provided as part of the lunch.

Each day there is home-made soup, a hot main course and sometimes a choice of main courses and a sweet. Alternatively, there are sandwiches or baked potatoes with a choice of fillings, and a choice of fruit or yoghurt instead of the sweet. There are always salads. A drink of juice / milk is always provided with the meal.

The term's menu goes home to each family and the daily menu is also posted on the school website. Vegetarian meals are provided on request, so please let the school know of any special dietary requirements your child has.

### **Packed Lunch**

Some children prefer to take their own packed lunches, and these are also eaten in the dining hall. Children are encouraged to make healthy choices in the packed lunches they bring to school.

### **Break Time Snacks**

A healthy option should always be the first choice when providing your child with a snack at break time e.g., peeled and cut fruit or vegetables, raisins. Salty crisps or chocolate biscuits not only create litter problems but are not the healthy option. Sweets, chewing gum and fizzy drinks are not permitted. There may be occasions where we request that children do not bring nuts into school due to allergies.

Glass bottles should not be brought to school.

## **1.11 Free School Meals**

All children up to the end of P5 are entitled to free school meals. No applications need to be made to the Education Service unless the pupil has an older sibling in P6-P7 who would also be entitled to free school meals. Applications for Free School Meals and Clothing Allowance are made on one form and should be submitted to Orkney Islands Council for each school year.

Application forms can also be obtained from the school and Orkney Islands Council (OIC) Customer Services. Applications must be submitted along with supporting documentation as detailed on the form. A new application is required for each school session. ## **1.12 School Transport**

Orkney Islands Council provides school transport for pupils who live out with walking distance, and the provision is described in the Authority's School Transport Policy.

Full details of the authority's School Transport including entitlement, catchment areas, collection / drop off points, code of conduct and provision for pupils with additional support needs is available on the following webpage:

Parents should remind their child(ren) that, in the interests of safety, good behaviour is expected from all pupils travelling on school transport.

Parents of P1-P3 pupils who walk to and from school are asked to accompany their children. Any P1-P3 pupil whose parent does not come to collect them will be taken to the school office and the parent phoned to come and collect their child.

Parents of children who walk to school are asked to remind their children to exercise care when crossing the road to the school gate. Younger children should be accompanied by an adult when crossing.

Cycle training is provided in term 1 for all P6 children. This gives information and training on the basic skills required when cycling on the road. We recommend that parents do not consider allowing their child to cycle to school until this training has been successfully completed and they are satisfied that their child has the necessary skills and wears a cycle helmet.

Parents are requested, when dropping off / collecting children from school, at the beginning and end of the school day not to stop in the designated bus parking area.

### **1.14 Transport for Early Learning and Childcare**

There is no provision of transport by the local authority for children in Early Learning and Childcare.

### **1.15 School Security**

Orkney Islands Council has introduced procedures to ensure the safety and security of pupils and staff when attending or working in a school. We use several security measures including a visitors' book, badges, and escorts, while visitors are within the school building. Normally, anyone calling at a school for any reason will be asked to report to the school office. The school staff then can make the necessary arrangements for the visitor.

### **1.16 Wet Weather Arrangements**

In wet weather pupils remain in school during breaks. Pupils are provided with indoor activities so that their break time is safe and happy. We have high expectations for behaviour and safety during indoor break as at other times of the school day.

### **1.17 Parental Consultation**

We offer opportunities for parents to discuss their child's progress with teachers through arranged meetings. All parents will be advised of when these occasions are. Over and above set meetings, parents are welcome to contact the school to ask for information or for an interview. Please see section two of this handbook for more details on home / school partnership.

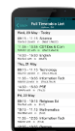
### **1.18 Communication with Home**

From time to time your child will bring home important and routine communications from the school. Parents are encouraged to check their child's schoolbag for these communications. Parents, who check their e-mails daily, may choose this electronic form of communication. Enquiries regarding school work should be addressed to the class teacher in the first instance.

We use GroupCall text messaging to communicate a range of information to parents.

## **1.19 Unexpected / Severe Weather Closures and Transport Disruption**

There can be several winter days where the weather causes disruption to schools and school transport. It is important to ensure that the school has your up-to-date contact details to inform you of any during-the-day closures. Information on school closures and transport disruption can be obtained as follows:

Early morning:

- OIC School Transport Facebook page is available; this may be your first stop for information on school closures and transport changes.
- The Facebook page and Twitter feed are both updated as soon as information is available. This can be as early as 6.30am to assist islanders' daily travellers in planning their travel. Information and links to these sites are available at:

- School closure information is passed to BBC Radio Orkney and broadcast on its programme at 7.30am (93.7 FM). Radio Orkney will be notified if there is disruption to transport and / or school closures. However detailed information on specific routes will not be provided.
- Information on school closures and transport disruption is also provided on the OIC answer phone (01856 873535) outwith office hours.

Note: In bad weather conditions it is very difficult to obtain individual route information to advise parents whether the school bus on their route is running that morning, because it will depend on the local weather and road conditions. We therefore are only able to advise whether there will be disruptions to school transport in general. Parents are best placed to know the road conditions in their area, and this will guide their decision whether to put their child out for school transport and how long they wait.

Throughout the school day:

- We contact parents if the school is closing, or transport is running early.
- Local media (Radio Orkney, The Orcadian) will also be notified of any disruption during the day.

## **1.20 Use of Electronic Devices, Including Mobile Phones**

Children and parents are asked to follow the school's guidance on the use of personal electronic equipment.

Mobile phones may not be brought to Glaitness School without good reason, for example, in case of emergency for a child who walks or cycles home. In these rare cases, the child should keep their phone switched off in their school bag. Children should not use or access their phone during the school day.

Orkney Islands Council is in the process of updating its policies on the use of personal electronic devices at school. In the meantime, if children take electronic devices into school, the school accepts no responsibility if they are lost, damaged or broken.

## **1.21 Equality**

Orkney Islands Council is committed to promoting equal opportunities, challenging discrimination, and fostering good relations, both in employment and in carrying out its work and delivering services, and we at Glaitness School are part of that commitment.

The Council is a member of Orkney Community Planning Partnership. The Partnership has developed an Equality and Diversity Strategy which determines how the community planning partners promote equality and diversity in the work they do. It also sets out how the public agencies and organisations within the Partnership are meeting their duties in terms of equality and diversity legislation, the needs of the local community and the aspirations contained in the Orkney Community Plan.

The Equality Act 2010 introduced a single equality duty covering the nine protected characteristics of age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation. The equality duty requires the Council to have due regard to the need to eliminate unlawful discrimination, victimisation and harassment, advance equality of opportunity and foster good relations across the protected characteristics. The message of the Act is that everyone has the right to be treated fairly, whether at work or when using services.

Education, Leisure and Housing has policies and statements to address equalities issues specific to education to enable us to fulfil these legal duties. All schools have copies of these policies.

## **1.22 English as an Additional Language**

The Authority provides a support service of teachers who offer information and advice to address the needs of pupils learning in their second language.

## **1.23 Complaints, Comments and Suggestions Procedure**

Orkney Islands Council Education Service is keen that you should be completely satisfied about your child's education, so we at Glaitness encourage feedback on our services from parents and pupils. We are, therefore, interested in feedback of all kinds, compliments, suggestions, or complaints.

If you want to register a comment of any type about the school you can do this by writing, e-mailing, telephoning, or making an appointment to see someone. All feedback is welcome and keeps us in touch.

If you have a complaint about the school, please let us know. It is better that these things are shared openly and resolved fairly, rather than being allowed to damage the relationship between the family and the school. There will be no negative consequences arising from making a complaint and we will deal with the issue as confidentially as possible. If we have made a mistake, we will apologise quickly and clearly and try to put things right.

There are some things which you should take note of in relation to making a complaint:

- Please make any complaints initially to the head teacher. This makes sure that the school knows what is going on and has an opportunity to respond to and resolve the issue.

- We will try to respond as quickly as possible, but often issues are complex, and we need time to investigate.
- If you are still unhappy with the service or with our response, then you have the right to take the matter further using the Orkney Islands Council complaints procedure. You can put your complaint in writing or fill in a complaint form, available in the school or any council office. We can help if you have difficulty with this. - If you are still unhappy after the further investigation and reply, you can take the matter up with the Scottish Public Services Ombudsman; our reply will include the contact details.
- You should also note that you have the right to raise unresolved concerns with your local councillor, MSP or MP

## **1.24 School Policies**

## **1.25 School Health Service**

Orkney Health and Care provides an Orkney-wide school health service to all school-age children and young people, to promote their health and wellbeing, and to provide them with information to make informed decisions on lifestyle choices. Our aim is that children and young people are as healthy as possible so they can gain the most benefit from their education, and that they will make healthy choices and therefore reduce the incidence of ill health in the future.

The service undertakes routine screening and is involved with child protection, health surveillance, health promotion and education, Human Papilloma Virus (HPV) vaccination and 1:1 support and advice. It can help any parents with parenting, through the Triple P Positive Parenting Programme, and help children and young people overcome bedwetting.

It also provides advice and support to education staff and delivers training on many health conditions that impact on childhood e.g., asthma, epilepsy, and allergies. It supports and coordinates paediatric clinics and acts as a link between consultants and parents / carers and children.

The School Nurse Team covers all schools in Orkney and comprises a public health nurse (specialist practitioner), registered nurse and healthcare support worker who are based in the School Health Department at the Kirkwall Health Centre Annex. Pupils, parents / carers can request information and advice at any time. Other health professionals and teaching staff can also request advice and input from the school nurse for a child with parental and / or the young person's consent.

- Health screening - All children in Primary 1 will be seen to have their height and weight growth checked.
- Immunisations - Secondary school girls are offered HPV immunisations. At the appropriate time information booklets and consent forms will be issued.

- Health Education and Promotion-The School Health Team has an important role in encouraging healthy lifestyles, working closely with teaching staff, pupils, parents / carers, and the community.

## **1.26 Infectious Diseases**

Colds, flu, and gastroenteritis are the most common infections affecting children of school age. It is important that you keep your child off school if they are unwell and for 48 hours after they stop vomiting or diarrhoea.

It is also important that your child understands how to prevent picking up and spreading such infections. Good, effective hand washing is one easy solution to preventing the spread of germs.

You will be able to get further advice about good health from staff in your health centre or GP practice.

For advice about early detection and treatment for other infectious diseases e.g., chickenpox and mumps, please consult your GP or nurse.

## **1.27 Head Lice**

The following is advice from the authority to parents on head lice, their treatment and prevention.

Head lice are spread through head-to-head contact at home, while playing, or in school.

Wet combing of your child's hair using a head-lice detection comb is the best way to detect and treat at an early stage and prevent the spread of head lice to family members and to other children and adults. Checking for head lice by wet combing should become a normal weekly routine.

The only way to be sure that your child has head lice is to find a live louse. If you find live lice, get the correct lotion from your doctor or pharmacist.

One treatment is two applications of the treatment lotion, seven days apart. If this is not followed, then re-infection is likely.

Advise family members and close friends that your child has head lice and that they should check their own hair. Only treat if live lice are found. Do not be shy about advising others of this possible problem, as you would tell family and friends about other infections which might affect them.

Further advice can be obtained from the Health Board head lice leaflet which is available in all schools and health centres. If you would like to discuss your particular concerns, you could speak to your GP.

## **1.28 Clinics and Appointments**

From time to time some children must attend clinics (eye clinics, dentist, doctor, etc.). Please inform the school of these visits and arrange for your child to be collected if he / she must leave school to attend the clinic.

No child will be allowed away from school during school hours unless accompanied by a responsible adult or unless written permission to do so has been given by the parent.

## 1.29 Medicine Administration

If pupils require medication to be administered at school, parents must contact the school office and **complete a standard form stating the name of the medication, dosage, time of administration and permission for staff to supervise.** School staff can only administer medicine that parents provide. Prescription medicines must have the dispensing chemist's prescription label on it, clearly detailing that it is the child's medicine.

For medical appointments during school hours, please notify the school by letter and collect your child from the school.

## 1.30 Insurance Cover for School Children

Insurance Cover details will be uploaded to the school website as soon as possible after the 31<sup>st</sup> of March.

# 2 Parental Involvement

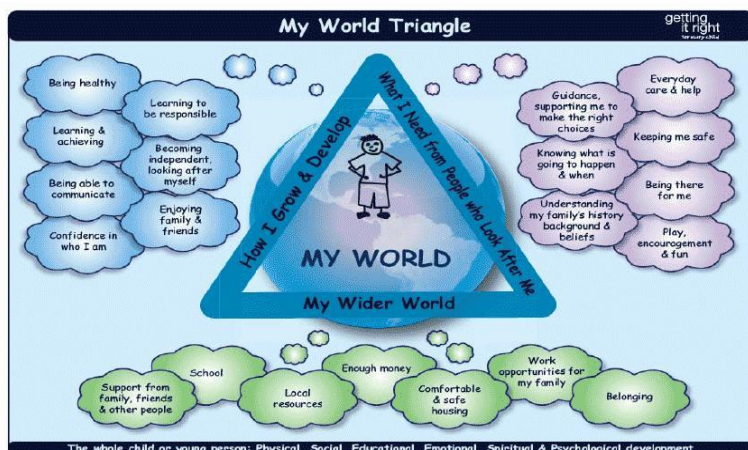
## 2.1 Parents as Welcome Participants in their Children's Education

At Glaitness we welcome parents as active participants in the life of the school, to be intrinsically involved with their child's education and learning, and to express their views on the school education generally and work in partnership with us. Children are shown to be more successful learners when parents involve themselves with their child's learning and the school. Learning is shared between pupils, parents and staff-members, through means such as, learning journeys, learning logs, homework diaries, class logs, school website, Glow, Seesaw. Other information is made available by letters; electronic means, where agreed; radio announcements, and so forth.

To encourage and support parents, Glaitness School holds parents' evenings, opportunities to come to sessions on developments in the school and the curriculum, to become active in school activities such as handwork, and after / out-of-school activities. At Glaitness, parents particularly take an active part in football, rugby, netball, and sometimes support classroom activities. Classes involve parents in different ways in their children's learning throughout the year. We also hold end of term services to which parents are usually invited.

## 2.2 Parent Councils

Parent Councils are the formal representative body for parents / carers with children attending school. The Glaitness School Parent Council is known as the Friends of Glaitness School (FoGS).



As a parent of a child in our school you automatically become a member of the Parent Forum, and if you wish, you can have greater involvement by becoming a member of the smaller group known as FoGS, which works together with everyone



involved in school life - parents, learners, teachers, school staff and the wider community - to support the school. Elections are held once a year at the AGM. FoGS meets once a term, with additional meetings when there are special events, e.g., preparing for a fundraiser or helping at parents' evenings.

Parents and families are children's first teachers and make a real difference to children's learning - when parents are involved children do better and achieve more. The range of support a child requires is demonstrated in the 'My World triangle', showing how all aspects of a child's life is important to ensure each child develops fully.

Parents are welcomed to:

- Be involved with their child's education and learning.
- Be active participants in the life of the school.
- Express their views on school education generally and work in partnership with their children's schools.

As automatic members of the Parent Forum, all parents can expect to:

- Receive information about the school and its activities.
- Hear about what partnership with parents means in our school.
- Be invited to be involved in ways and times that suit you.
- Identify issues you want the parent council to work on with the school.
- Be asked your opinion by the parent council on issues relating to the school and the education it provides.
- Work in partnership with staff.
- Enjoy taking part in the life of the school in whatever way possible.

The Parent Forum decides how its representatives on FoGS are chosen and how FoGS operates. Parents / carers are encouraged to volunteer or put themselves forward to be chosen as representatives on FoGS if they wish.

The main aims of FoGS are to:

- Support the school in its work with pupils.
- Represent the views of parents.
- Promote contact between the school, parents, pupils, providers of nursery education and the community.
- Report to the Parent Forum.
- Be involved in the appointment of senior promoted staff.
- Raise funds for the school for the benefit of pupils.

## 3 School Ethos

### 3.1 Vision Statement

At the heart of our vision lie the core values we all share in our learning community. These are aspirational and are developed in line with local and national educational values.

  - We are ready to enjoy learning inside and outside our school.

Pupils' achievements in and out of school are celebrated regularly at assembly, on notice boards, class blogs, school website, and with the wider community through local media e.g., Radio Orkney.

Glaitness School is at the heart of its community. We value our links with many community groups such as the King Street Church, Orkney Rugby Football Club, Orkney Youth Development Group, Orkney Netball Association to name but a few. We have a range of helpers who visit the school throughout the year to help the children, local charities, RSPB, the Orkney Rangers' Service, Orkney College UHI, St Magnus Festival, Orkney Folk Festival.

### 3.2 Curriculum Rationale

At Glaitness School, learning and teaching experiences are underpinned by our school values. We empower children to take an active role in their learning through:

- Planning opportunities which are responsive to their developmental needs and individual interests
- Committing to an inclusive approach to learning and teaching across all classes
- Engaging in experiences that reflect individual interests, local, national and international events, issues and initiatives.
- Providing opportunities for children to reflect on their own and other's learning, identifying appropriate next steps.

Glaithness School is at the heart of its community. Our curriculum reflects our setting and the individual needs of our learners. We make use of our outdoor environment and local facilities as a tool to enhance and enrich children's learning. We develop our learner's skills for life, learning and work. We actively seek opportunities for children to contribute to and be involved in their community. We develop experiences that enable children to develop their understanding of Kirkwall and Orkney, valuing our unique location, culture, history, and heritage.

Through effective use of our enhanced resources and facilities we promote and support children's learning and wellbeing. We create a supportive learning experience for all children, especially those with complex needs, and this is supported further through our enhanced relationships with parents.

We embrace opportunities for whole school learning, including the promotion of shared and family learning. We recognise and celebrate children's wider achievements, fostering opportunities for them to further develop as successful learners, confident individuals, effective contributors, and responsible citizens.

We enable children to develop as global citizens who have an understanding, awareness, tolerance and respect of different needs and cultures through engaging them in learning about real-world issues. Through taking account of broad, topical and cross-cutting themes we enable children to develop the transferrable skills they will need for lifelong learning in an ever-changing world.

### **3.3 Pupil Conduct**

A partnership between the school and parents is required to ensure the best possible standards of pupil conduct. Pupils are expected to set themselves high standards in appearance and behaviour. School rules have been devised with staff, pupils and parents to allow for the smooth running of the school. The general aim is to produce an atmosphere of friendly co-operation, encouraging respect and consideration for other persons and for property.

#### **RIGHTS AND RESPONSIBILITIES**

Everyone has the right to feel happy and safe. It is everyone's responsibility to help others feel happy and safe.

Everyone has the right to take part in learning activities with a positive attitude and the responsibility to contribute to a positive learning environment.

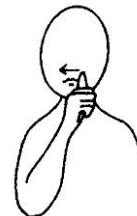

## 4 School Curriculum

### 4.1 Curriculum for Excellence

“Bringing learning to life and life to learning”.

Curriculum for Excellence has now been introduced across Scotland for all 3- to 18-year-olds - wherever they learn. It aims to raise standards; prepare our children for a future they do not yet know and equip them for the jobs of tomorrow in a fast-changing world.

Glow, Scotland’s unique, world-leading, online network supports learners and teachers, and plans are already in place for parents across the country to have access to Glow. Parents should ask the school how to arrange access to Glow and a username and password will be issued.

Teachers and practitioners will share information to plan a child’s ‘learning journey’ from 3 to 18, helping their progression from nursery to primary, primary to secondary and beyond, ensuring each transition is smooth. They’ll ensure children continue to work at a pace which they can cope with and with challenge they can thrive on.

Curriculum for Excellence balances the importance of knowledge and skills. Every child is entitled to a broad and deep general education, whatever their level and ability.

Every single teacher and practitioner is responsible for the development of literacy and numeracy from Early Level through to Senior Phase.

Curriculum for Excellence aims to develop skills for learning, life and work, bringing real life into the classroom, making learning relevant and helping young people apply lessons to their life beyond the classroom. It links knowledge in one subject area to another, helping make connections in their learning. It develops skills which can enable children to think for themselves, make sound judgements, challenge, enquire and find solutions.

There is an entitlement to personal support to help young people fulfil their potential and make the most of their opportunities with additional support wherever it is needed. There is an emphasis on looking after our children’s health and wellbeing - to ensure that the school is a place where children feel safe and secure.

Ultimately, Curriculum for Excellence aims to improve our children’s life chances, to nurture successful learners, confident individuals, effective contributors, and responsible citizens, building on Scotland’s reputation for great education.

Curriculum for Excellence aims to achieve a transformation in education in Scotland by providing an improved, more flexible, and enriched curriculum for all children and young people from 3 to 18. The curriculum includes all the experiences which are planned for children and young people through their education, wherever they are being educated. At Glaitness, we are working hard to raise standards so that children and young people will develop all the skills necessary to continue to be successful when leaving school and entering the world of higher education, training or work.

Curriculum for Excellence is underpinned by the values inscribed on the mace of the Scottish Parliament: “Wisdom, justice, compassion and integrity”.

The purpose of Curriculum for Excellence is encapsulated in the four capacities - to enable each child or young person to be: a successful learner, a confident individual, a responsible citizen, and an effective contributor.

There are eight curriculum areas:

- Expressive Arts (art, music, dance, and drama)
- Religious and Moral Education.
- Health and Well Being, including Physical Education.
- Sciences.
- Languages (listening, talking, reading, writing and other languages).
- Social Studies.
- Mathematics (numeracy).
- Technologies.

Literacy, numeracy, and health & wellbeing are given added importance because these skills are so vital in everyday life. All teachers will have responsibility to teach literacy, numeracy, and health & wellbeing.

Learning is divided into two phases.

### **The General Phase**

The General Phase is from Nursery to the end of Secondary School third year. Learning in the General Phase is divided into levels as follows:

- Early - the nursery years and P1, or later for some.
- First - to the end of P4, but earlier or later for some.
- Second - to the end of P7, but earlier or later for some.
- Third and fourth - S1-S3, but earlier for some.

### **The Second Phase**

The Second Phase is from fourth year in Secondary School, and beyond S4 - S6 which can include College as well as Secondary School.

### **English Language**

Our Language programme is based on the national guidelines for "A Curriculum for Excellence".

#### **Speaking**

Much attention is given to this important aspect of language, our aim is to enable children to express their ideas and thoughts in a concise and articulate manner. We follow guidance in Orkney's Listening and Talking Toolkit.

#### **Listening**

It is our policy to devise strategies which will assist the pupils to become good listeners, thus creating conditions for more effective learning. We follow guidance in Orkney's Listening and Talking Toolkit.

## **Reading**

The school uses a variety of published resources to support the teaching of reading, including Oxford Reading Tree resources. This approach is backed up using appropriate phonic material (Jolly Phonics). We aim to make our pupils effective readers, commanding all the skills necessary for reading with understanding, enjoyment, and appreciation. The school has adopted Orkney's toolkit for reading and strategies to develop literacy skills.

## **Writing**

Our aim is to encourage fluent expression, factual accuracy, and formal "correctness" (punctuation, spelling etc.) in the different forms of writing tackled by the children. The purpose of their writing will be to convey information, express feelings, reflect on ideas and opinions and give imaginative and aesthetic pleasure.

## **Modern Languages**

Currently children are learning French from P1.

## **Mathematics**

The school's Mathematics programme is based on the guidance in "A Curriculum for Excellence". Learning mathematics gives children access to the wider curriculum and the opportunity to pursue further studies and interests.

Mathematics is sub-divided into:

- Number, Money, and Measurement.
- Problem Solving.
- Information Handling and Shape, Position and Movement.

It is our aim to help the pupils acquire the basic mathematical facts and skills and to enable them to put these to practical use.

Emphasis is also placed on mental arithmetic and problem solving.

We use a range of resources at each stage to ensure progression, challenge, breadth, depth, and enjoyment. We emphasise the need to make maths relevant to everyday life.

## **Interdisciplinary Topics**

These embrace aspects of History, Geography, Local Studies, Science and Health and Wellbeing. Children are taught certain basic skills and ideas through Environmental Studies. For example, they are taught the skills of observation, researching, classification and recording. Emphasis is placed on local and Scottish themes.

Visits are made to places of local interest, for example Corrigall and Kirbister museums, Skara Brae, Ring of Brodgar, St Magnus Cathedral.

Our programme of study has been put together by Glaitness staff ensuring a range of topics which will engage and motivate the children, helping to make links across the curriculum and across their learning. It is this ability to make links that takes learning into new dimensions.

Staff consider interests of the children, prior knowledge and personalization when planning learning experiences and outcomes.

## **Art**

Children are taught the basic techniques of drawing and painting. They are given the opportunity to work with different types of material, e.g., paint, clay, fabric etc.

## **Music**

Children sing, play instruments, make their own music, and recreate that of others and other cultures, and learn about pitch, rhythm, and harmony.

At P4, violin tuition is offered to pupils, and at P6 and 7 stages woodwind is additionally offered. Throughout the year, older children can join the orchestra and/or choir for key school events.

All children who learn an instrument, or sing in the choir, are asked to commit to performing in concerts in school or in the community throughout the year.

## **Physical Education and Health and Wellbeing**

Our itinerant PE teacher teaches a basic moves program to early and first level pupils through a variety of topics including gymnastics, athletics, active health, dance, and games.

An Active Schools Coordinator works closely with the school to provide opportunities for pupils and support for class teachers in delivering quality PE each week. The school follows Government guidelines and delivers 2 hours of Physical Education each week.

The programme for health and wellbeing, includes aspects of physical, social, and emotional health. All our pupils take part in the Childsmile Toothbrushing Campaign, and children from nursery to primary 2 can have their teeth painted with enamel.

## **4.2 Active Learning**

Curriculum for Excellence emphasises the value of an active learning approach. In the early years, children will have a range of learning experiences that include planned and purposeful play and stimulating learning which engages and challenges children's thinking using real-life and imaginary situations. As children progress through school, they will continue to be involved in active learning experiences which are engaging and give them ownership of their own learning.

## **4.3 Planning Children's and Young People's Learning**

Teachers in nursery, primary and secondary schools share their learning intentions with pupils, parents and carers. This takes place with pupils on a day-to-day basis by agreeing the aims of an individual piece of work. Longer-term planning also takes



place in a variety of forms. Pupils in primary schools negotiate with their teachers their aims for the next block of learning. At the end of the block progress against these aims is assessed by the teacher and pupil, and new targets are set for the following block of learning.

There are many opportunities in school for children to make choices in their learning: for example: topics for writing, studying of a particular area or character of interest in greater depth, how work is presented for evaluation or generally, personal targets for learning and so on.

#### **4.4 Homework**

Pupils are regularly given homework to support their learning and to encourage them to become more organised and self-supporting in their learning. Homework tasks will be given where a teacher feels a particular child or group of children may benefit from it. Homework will be organised according to the stage and ability of the child; it can arise from all curricular areas and may include written, oral, or practical activities. The tasks set will be interesting, worthwhile, and challenging for the child.

Parents are encouraged to help pupils with their homework as a means of keeping them up to date with the work of the class and the child's progress, and to promote partnership between the school and parents.

Homework provides an opportunity to consolidate what has been learned in class and helps parents be aware current learning. This can be a useful discussion starter at home. Homework is also an integral part of schoolwork. Parental interest and co-operation in ensuring homework is undertaken is essential. We encourage parents to sign/acknowledge each homework task.

#### **4.5 Care of Books / Materials**

To enable us to provide the best possible education for your child, every care should be taken to look after the school's resources and facilities. Parents are asked to remind their child(ren) that all school equipment and fitments should be used with care.

Books and learning resources which are lost or destroyed must be paid for, either wholly or in part. Any loss of school or Council property should be reported immediately to the school.

#### **4.6 Sensitive Aspects of Learning**

Education in relation to sexuality and relationships is specifically taught in P6 and P7. However, building blocks relating to this are built into the health and wellbeing education throughout the school. The programme is supported by a member of the NHS Orkney team. We will notify parents about sensitive aspects of learning through the class notices.

Children at this stage are informed about drugs and their effects.

#### **4.7 Religious Instruction and Observance**

Parents who wish to exercise their right to withdraw their child from religious instruction and / or observance should contact the head teacher, in writing, and alternative arrangements will be made for your child.

## **4.8 Extra-Curricular Activities and School Excursions**

### **Extra-curricular activities**

Every school is encouraged to offer as wide a range of sporting and cultural activities as possible. In this context, the Authority provides a degree of financial and administrative support for leagues, competitions, festivals, and similar events but it is recognised that, again, the help of parents and the community is invaluable.

At Glaitness, there is a range of extra-curricular activities available for pupils after school, and parents will be informed about these by the school. In addition to in-school activities, classes also make regular educational visits and excursions. Wherever possible, these excursions are linked to pupils' learning.

All our in-school activities are supervised by members of staff or other responsible adults, and where participation involves children travelling or staying late after school, written permission for children taking part is required from parents. Our parent council and parent helpers also support extra-curricular activities; we encourage parents to contact the school if they wish to volunteer to support after school activities.

### **School Trips**

Various school trips are organised for the children throughout the year. These are an important aspect of the children's learning. The Council's safety procedures are adopted, and parental consent sought before all trips to ensure the safety and enjoyment of everyone taking part.

### **Safety**

All school activities are subject to risk assessments which ensure that any hazards involved are identified and managed appropriately.

Whenever parental consent is required, the school will issue the appropriate form. This will include consent for:

- Trips and excursions.
- Administering medicine.
- Using pupils' images out with the school i.e. newspaper reports.
- Use of internet.
- Use of school sun cream.

## **4.9 Facilities for Physical Education and Outdoor Activities**

The school hall / gym has a variety of apparatus for physical education. As part of the school's physical education programme, pupils may at times also use the facilities of the local sports complex, swimming pool or sports pitches.

## **4.10 Active Schools**

The Active Schools Network in Scotland is a team of people working in the school and the wider community. Its goal is to offer all children and young people the motivation and opportunities to 'get active', ensuring there are more and higher quality opportunities for all children to participate in sport in schools and to increase capacity through the recruitment of a network of volunteers, who in turn deliver activity sessions in schools. ## **4.11 Outdoor Education**

Rich in culture and community, set in a diverse, exciting, even exhilarating environment, Orkney has an outdoor education provision set to reflect its own status. Outdoor Education opportunities, especially those with a residential element, play an important part in promoting the personal and social development of pupils of all abilities, as well as contributing to their understanding of environmental and developmental education themes.

Sometimes the focus of activities will be on the development of skills, at other times on the process by which learning occurs, or by the provision of opportunities for learning through direct experience. The range of Outdoor Education and the development of diverse activities create a need for instructors and teachers to be flexible in their approach. Teaching and instructional styles have clear emphasis on the needs of the individual and the group.

At Glaitness, children are given the opportunity to undertake various school trips, some onsite, some in the school's extended campus, i.e. Muddisdale Woods and others further afield.

## **4.12 Assessment and Reporting your Child's Progress**

In accordance with national policy, a baseline assessment is completed for all children on entry to P1, then again in P3, P5 and P7. Baseline assessment enables a snapshot of where individual children have reached in their literacy and numeracy development. The assessment helps teachers plan for learning.

Pupils in P1, P4 and P7 undertake Scottish National Standard Assessments in reading, writing and maths. School receives feedback on these assessments to enable teachers to plan next steps in learning for pupils.

Assessment is of a continuous nature; each pupil being assessed on his / her general class work in conjunction with class tests whenever appropriate. A variety of assessments and strategies will be used to confirm that a child is ready to move from one level to the next.

Pupil's progress will be notified to parents throughout the session and through the parents' evenings in November and March. A summary of learning for the year is reported to parents in June through each child's Learning Journey.

School staff will share aspects of learning and next steps with parents throughout the year in various ways, including through learning logs, a termly letter with information about the forthcoming term. Where staff have concerns about a child's learning, he / she will contact parents to share these. Parents wishing to discuss their child's progress with the class teacher are welcome to contact the school at any time to ask for an appointment to consult with the class teacher or head teacher/depute head teacher.

At P7 pupils complete a profile of their achievement which goes with them to secondary school. This provides an opportunity for one-to-one dialogue about learning with secondary staff.

The purpose of the profile is to:

- provide learners with a reflective summary statement of their achievement.
- publicly recognise progress in their learning and achievement.

- challenge, motivate and support all children to achieve their best.
- build learners skills and capabilities to reflect on their learning.
- support and inform transition.

If you have any concerns about your child's progress, please get in touch with us as soon as they arise.

Parents can discuss their child's progress with class teachers on parents' evenings. In addition, of course, parents are welcome to contact the school to ask for information or for an appointment to consult with the head teacher or class teacher.

More information about what data is collected about your child is given in section seven of this handbook.

## **5 Transitions**

### **5.1 Transfer from Early Learning and Childcare to Primary**

As children move into Primary One, Early Years staff will undertake a variety of planned activities with the children to enable a smooth transition.

### **5.2 Primary School Admissions**

In Orkney, as in all Scotland, there is one intake to primary school that takes place in the August of each year. Children born between the beginning of March and the end of the following February are eligible to start primary school in the August when they will be between 4.5 and 5.5 years old.

Children born between March and August must start school in the August after they become five. However, if your child is not five at the start of the school term in August, they have the option of deferring their entry to school until the following August.

Some parents / carers, therefore, have a choice as to when their child starts primary school. Taking the choice to delay school enrolment for a year is known as deferred entry. This choice takes place when your child will be starting Primary One, not when they are going into their pre-school year.

#### **Deferred entry to Primary School**

Parents / carers who have any concerns about whether they wish their child to take up a place in Primary One the following August should in the first instance discuss the matter with the Early Years staff, or the head teacher / manager of your child's school / setting. Discussions should focus on your child's progress in his / her pre-school education, and their readiness for P1.

#### **Request for Deferral**

If after on-going discussions with the nursery staff, you wish to proceed with a request for deferral to Primary One, you should complete the "Deferred Entry to Primary School" form. Your child's school / setting will have this form and nursery staff can support you to fill it in if you wish. You will need to return this to Education & Leisure Services by the end of March. We may not always be able to accommodate this request, always depending on our numbers but staff will communicate with you about this process and what is available.

## Automatic Deferral

If your child's birthday is in January or February, they will have the right to start school. They will also have the right to defer entry to Primary One and the local authority will provide a free pre-school place for an additional year.

## Discretionary Deferral<sup>[MT9]</sup>

If your child's birthday is from September to December, they will have the right to start school. They will also have the right to defer entry to Primary One.

The local authority may provide a free nursery place where there is agreement between parents / carers and the nursery staff that this is in the best interests of your child, and where there is a space at the nursery setting. However, the allocation of a free nursery education place is not automatic and is at the discretion of the local authority.

As part of this you may be offered fewer pre-school sessions if these are available. Alternatively, you may be offered a place in another setting where spaces exist.

Legislation is due to come into force under which the Local Authority will be obliged to provide an ELC place for a further year for anyone who wishes not to send their child to school (if they have not yet turned 5 by the August start date).

## Appeals and Decisions

Particularly in those cases where there may be doubts as to the final decision on deferral, parents are strongly advised to make an application for a primary school place too.

Advice on procedures for this is available from all primary schools and from the authority. This will ensure that each child's application for a primary school place can be considered by the due date (Early May). You will hear about any decisions in early May. Gaitness staff will also be happy to discuss any aspect of this with you.

When beginning Primary 1, your child will normally attend their local primary school and transfer from it, after Primary 7, to its associated secondary school. Details of the catchment areas and boundaries can be obtained from Education, Leisure and Housing - telephone 01856 873535 or email [education.leisure@orkney.gov.uk](mailto:education.leisure@orkney.gov.uk).

Children eligible for enrolment are those whose 5th birthday falls on or between 1st March and the end of February the following year. Any pupil who wishes to transfer to a school out with the catchment area will need to submit a Placing Request Form.

## 5.5 Primary to Secondary Transfer and the Catchment Secondary School for the East Mainland

Gaitness School falls in the catchment area for secondary education of Kirkwall Grammar School (KGS), and pupils from Gaitness School normally transfer there after primary 7. The P7 Class Teacher, Support for Learning Teacher, and Head teacher liaise with secondary guidance staff and collate information about pupil progress, attainment, and successful teaching strategies before Primary 7 pupils move into secondary school.

Transition is further enhanced through participation in curricular projects and visits by secondary teachers.

In June P7 pupils take part in two transition-day visits to KGS. On these days, pupils get the opportunity to participate in lessons in classes they will be in S1.

If children are eligible, they will be able to apply for bus transport.

As well as the transition days, pupils also attend Active Schools Sports events and music opportunities designed to help make new social ties with children from other schools.

Other visits may be arranged from time to time and the children meet each other and KGS staff through music and sport activities.

Parents will have an opportunity to view the school and be given a brief explanation of school life. For further information, contact Kirkwall Grammar School:

If you wish your child to attend a secondary school other than the catchment secondary school for your home address, you will be required to make a Placing Request as detailed in the Placing Request section below.

## **5.6 Placing Requests**

As a parent, you have the right to make a Placing Request for your child(ren) to be educated in a school other than the local school. Applications for Placing Requests should be submitted in writing to:

As soon as a decision has been made, you will be notified of the result. If your Placing Request is successful, you will be asked to contact the school to establish arrangements for enrolment.

## **5.7 Mid-Session Transfers**

You may make a Placing Request at any time during a school session. If your child is experiencing problems at school, you are advised to discuss the matter with the Head Teacher prior to making a Placing Request. Completing the Application Form does not guarantee a place for your child at your chosen school. Your Placing Request will only be granted if there are surplus places available at the school.

## 5.8 Transport for Placing Requests

If a Placing Request is successful, parents will be responsible for the safety and transportation costs of their child to and from their chosen school.

## 6 Support for Pupils

### Getting It Right For Every Child (GIRFEC)

Taking care of our children's well-being and making sure they are alright - even before they are born - helps us ensure the most positive outcomes for them later in life. It gives them the potential to grow up ready to succeed and play their part in society.

Getting it right for every child is a programme that aims to improve outcomes for all children and young people.

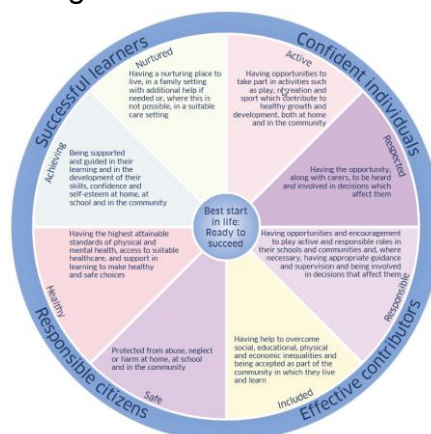
It promotes a shared approach that:

- builds solutions with and around children and families.
- enables children to get the help they need when they need it.
- supports a positive shift in culture, systems, and practice.
- involves working together to make things better.

Getting it right for every child is the foundation for work with all children and young people, including adult services where parents are involved. It builds on universal health and education services and is embedded in the developing early years and youth frameworks. Developments in the universal services of health and education, such as Better Health Better Care and Curriculum for Excellence, are identifying what needs to be done in those areas to improve outcomes for children.

The Getting it Right approach looks at eight areas of 'well-being'. These are recognised as areas in which children and young people need to progress in order to do well now and in the future. They allow those responsible for the care and support of children - including members of their own families - to look at a situation in a structured way that will help them identify any needs and concerns and plan with the child and family any action they need to take. The eight well-being indicators are:

- Safe
- Healthy
- Achieving
- Nurtured
- Active
- Responsible
- Respected
- Included



The approach gives them a common language and a way to gather information about a child's world, making sure the child is growing and developing, and has everything they need from the people who look after them both at home and in the wider community. It also encourages practitioners to think about who else might need to be involved (for example a teacher might need to contact other professionals to make

sure that an education improvement plan with the child and family was meeting all the child's needs).

## **Protecting Children and Young People**

All children have a right to be protected from harm, abuse and neglect. It is everyone's job to make sure that children in Orkney are safe. Education, Leisure & Housing have an important role in identifying children who have been abused or are at risk of being abused.

Orkney Islands Council has clear procedures for all staff to follow. Head Teachers or designated member of staff are instructed to notify Orkney Islands Council when a member of staff has a suspicion that a child might have been abused or be at risk of abuse. This encompasses a wide range of risks including concerns about emotional abuse or harm.

Orkney Health & Care will decide on whether or not an investigation is necessary and will advise accordingly. In every situation for all staff, the welfare of the child overrides other considerations.

## **Additional Support Needs – Mainstream Classes**

Pupils with additional support needs are identified by class teachers working with the support for learning teacher and when appropriate, the educational psychologist. Provision is made for pupils with additional support needs based on assessments in school and on professional advice.

If you believe your child to have any additional needs, please speak to the class teacher in the first instance or to the Head Teacher at any time.

## **Educational Psychology Service**

The Educational Psychology Service is part of the Pupil Support sector within Education, Leisure & Housing. The central aim is to promote the development and well-being of children and young people (birth to 24 years), particularly to help them overcome any barriers to learning and self-efficacy. The service aims to achieve this through working collaboratively with teachers, parents, young people, and others.

## **Pastoral Support**

Glaithness School is a warm and caring place and pastoral support is always available from members of staff as well as through our partner agencies. If you believe your child needs additional pastoral support, please speak to the class teacher in the first instance.

In addition to the information shown above, the school handbook must include information specified by the Education (additional Support for Learning) (Scotland) Act 2009 which includes:



- the authority's policy in relation to provision for additional support needs.
- the arrangements made by the authority in making appropriate arrangement for keeping under consideration the additional support needs of each such child and young person and the additional support needs of the children and young person so identified.
- the other opportunities available under this Act for the identification of children and young persons who:
  - have additional support needs.
  - require, or would require, a co-ordinated support plan.
- the role of parents, children and young persons in the arrangements referred to above.
- the mediation services provided.
- the officer or officers of the authority from whom parents of children having additional support needs, and young persons having such needs, can obtain advice and further information about provision for such needs.

School Handbooks must also contain information of any organisations specified by Scottish Ministers which provide advice, further information and support to parents of children and young people with ASN. These organisations are identified under The Additional Support for Learning (Sources of Information) (Scotland) Amendment Order 2011 as:

## **7 School Improvement**

### **Raising Attainment**

Monitoring performance and using the resulting information to secure improvement is an important part of the work of head teachers, school staff and officers within Education Services.

The Scottish Schools Dashboard

### **Standards and Quality Report**

Every year each school publishes a Standards and Quality report which highlights the school's major achievements. Each parent receives a copy of the report, which can also be found on the school website.

### **School Improvement Plan**

Each session the school publishes a School Improvement Plan which can be found on the school website. Priorities can be found on the School Improvement Plan on the website.

## **Transferring Educational Data about Pupils**

The Scottish Government – Education and Training has asked that the undernoted advice be included in our school brochures.

Education authorities and the Scottish Government collected data about pupils on paper forms for many years. We now work together with schools to transfer data electronically through the ScotXed programme. Thus, the Scottish Government has two functions: acting as a 'hub' for supporting data exchange within the education system in Scotland and the analysis of data for statistical purposes within the Scottish Government itself.

### **What pupil data is collected and transferred?**

Data on each pupil is collected by schools, local authorities, and the Scottish Government. The data collected and transferred covers areas such as date of birth, Scottish Candidate Number (SCN), postcode, registration for free-school meals, whether a pupil is looked after by his/her local authority, additional support needs including disability and English as an Additional Language (EAL), and attendance, absence and exclusions from school. The SCN acts as the unique pupil identifier. Pupil names and addresses are not passed to the Scottish Government. Your postcode is the only part of your address that is transferred for statistical purposes, and postcodes are grouped to identify 'localities' rather than specific addresses. Dates of birth are passed on as 'month and year' only, again to ensure that individuals are never identified. Data is held securely and no information on individual pupils can or would be published by the Scottish Government.

Providing national identity and ethnic background data is entirely voluntary. You can choose the 'not disclosed' option if you do not want to provide this data. However, we hope that the explanations contained in this message and on the ScotXed website will help you understand the importance of providing the data.

### **Why do we need your data?**

In order to make the best decisions about how to improve our education service, the Scottish Government, education authorities and other partners such as the Scottish Qualifications Authority and Skills Development Scotland need accurate, up-to-date data about our pupils.

We are keen to help all our pupils do well in all aspects of school life and achieve better examination results. Accurate and up-to-date data allows us to:

- plan and deliver better policies for the benefit of all pupils
- plan and deliver better policies for the benefit of specific groups of pupils
- better understand some of the factors which influence pupil attainment and achievement
- share good practice
- target resources better.

### **Your data protection rights**

The collection, transfer, processing and sharing of ScotXed data is done in accordance with the Data Protection Act (1998). We also comply with the National

Statistics Code of Practice requirements and other legislation related to safeguarding the confidentiality of data. The Data Protection Act gives you the right to know how we will use your data. This message can give only a brief description of how we use data. Fuller details of the use of pupil data can be found on the ScotXed website [www.scotxed.net](http://www.scotxed.net).

The Scottish Government works with a range of partners including Education Scotland and the SQA. On occasion, we will make individual data available to partners and also academic institutions to carry out research and statistical analysis. In addition, we will provide our partners with information they need in order to fulfil their official responsibilities. Any sharing of data will be done under the strict control of the Scottish Government, which will ensure that no individual level data will be made public as a result of the data sharing and that these data will not be used to take any actions in respect of an individual. Decisions on the sharing of data will be taken in consultation with colleagues within and out with the Scottish Government.

## **8 Glaitness School – Enhanced provision.**

**What we offer children and young people with moderate to complex additional support needs who are allocated a place at Glaitness in a supported class.**

‘Be all you can be’ is our motto and we aspire to make this happen for all our learners. Our focus for our learners with additional support needs is to provide opportunities and structure to increase independence in learning and in daily life. We have an enhanced level of staffing at the school which enables us to have some supported classes which can provide individual or small group learning as part of a planned programme. Within this planned programme for individual children, opportunities for learning in the mainstream classes are also built in where appropriate to the needs of all children.

We provide flexible learning activities and sometimes spaces which are planned and used to meet individual needs. We regularly use a range of visual aids, prompts, symbols and pictures to facilitate communication and independence. These are often shared with home for parents and children to use together.

We have very regular communication with parents in relation to all aspects of their child’s learning and care including setting targets, reviewing progress and planning and meeting care or health needs. Relevant training is put in place to enable staff to be trained and confident in addressing a wide range of needs.

We have regular and on-going communication with our partner agencies and colleagues working very closely with Children and Families’ team at OIC, NHS Orkney and the support team based within Education, Leisure and Housing Services.

We have a fully accessible physical environment which includes some special places to enhance learning and experiences for some children. The special spaces include a sensory room, and a hydrotherapy pool. We maximise the use of the close local environment with many visits out into the local community around Kirkwall and we can go further afield with the use of the school minibus. We access facilities and activities in the local area with regular swimming sessions and horse-riding for some children.

### **Additional Information**

Children are placed in a supported class at Glaitness following multi-agency involvement and agreement from all that this is the best provision for your child. This includes agreement from parents. Transport if requested may be available for children placed in supported classes but families will be assessed for the need for transport by the Educational Psychologist. If your child is allocated a placement in a supported class, we will hold a placement review within approximately 8 weeks with parents and all relevant agencies to ensure this placement meets the needs of the child.
